Subject: BURLEIGH EO - use of concessionally registered vehicles

Document ID: DLO3904

- The Department of Transport and Main Roads (TMR) offers vehicle registration concessions to charitable and community service organisations, provided they meet a specific eligibility criteria.
- The eligibility criteria includes that the organisation:
 - is registered as a charity with the Australian Charities and Not-for-Profits Commission
 - is listed as a Public Benevolent Institution
 - is listed as a Tax-Deductible Gift Recipient, and
 - provides help, relief or support to persons in distress.
- TMR confirms the two vehicles that Mr Hart identified in his correspondence are not in receipt of a charitable or community service concession.
- While the vehicles have a Purpose of Use (POU) listed as 'Used for Non-Profit', this does not provide any form of concessional benefit on the vehicle's registration.
- Registered operators have the option of choosing their own POU when registering their vehicle. It is therefore possible for a 'Used for Non-Profit' POU to be applied to vehicles that are not in receipt of a concession.
- The POU for 'Used for Non-Profit' is defined as 'A vehicle used by a non-profit organisation (includes charitable and community service organisations or a legal entity created by legislation)'. Further to this, it is the customer's responsibility to inform TMR that they are a non-profit organisation, this does not have to be verified.

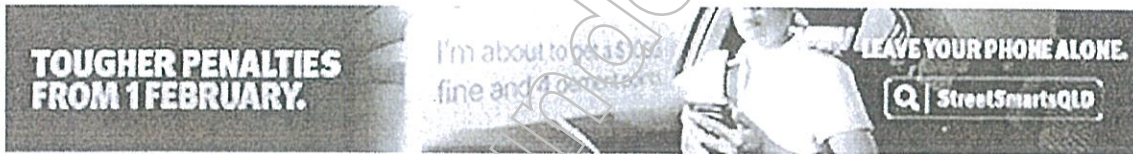

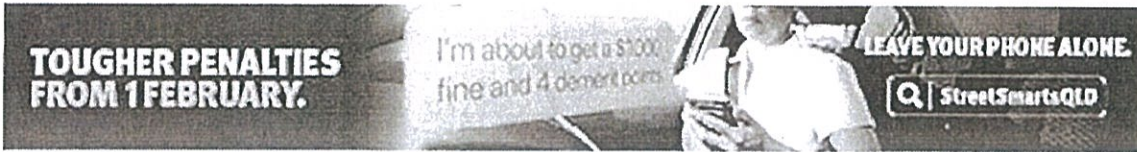

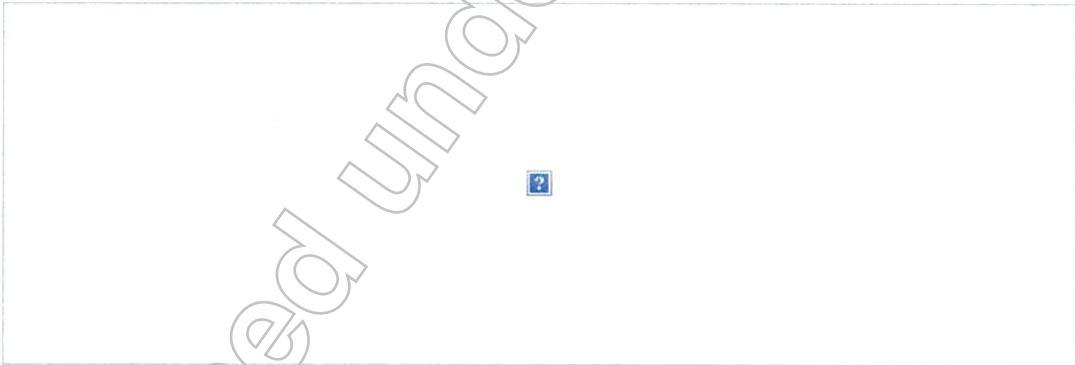
